

INTERLOCAL AGREEMENT

Comes now the Common Council of the City of Greenfield, Indiana, the Board of Works and Public Safety of the City of Greenfield, Indiana, the Commissioners Hancock County, Indiana, and the County Council of Hancock County, Indiana, and enter into an Interlocal Agreement pursuant to Indiana Code 36-1-7, said agreement to be as follows:

1. Purpose. The purpose of this agreement is to define the terms and conditions under which the City of Greenfield, by and through the Greenfield Fire Territory shall have available, basic life support and / or advanced life support emergency medical services to the residents of Hancock County, Indiana, outside of Center Township, seven (7) days a week, twenty-four (24) hours each day for the year 2010.

2. Payment. Hancock County shall pay to the Greenfield Fire Territory the sum of \$125,000.00 in two payments of \$62,500.00 each, on or before June 30 and December 31, 2010. This amount is above the amount paid by the Interlocal contracts paid by individual townships.

3. Terms. Hancock County, Indiana shall be billed a fee for use of service for residents of Hancock County Jail, Hancock County Community corrections and Hancock County employees sick or injured while working, based on the current rates adopted by the City of Greenfield.

4. Termination. This agreement terminates December 31, 2010, and when it terminates it does not reinstate the previous agreements.
