My name is Matthew Bates and I am the Retirement Plan Advisor for your Hoosier START Deferred Compensation Retirement Plan.

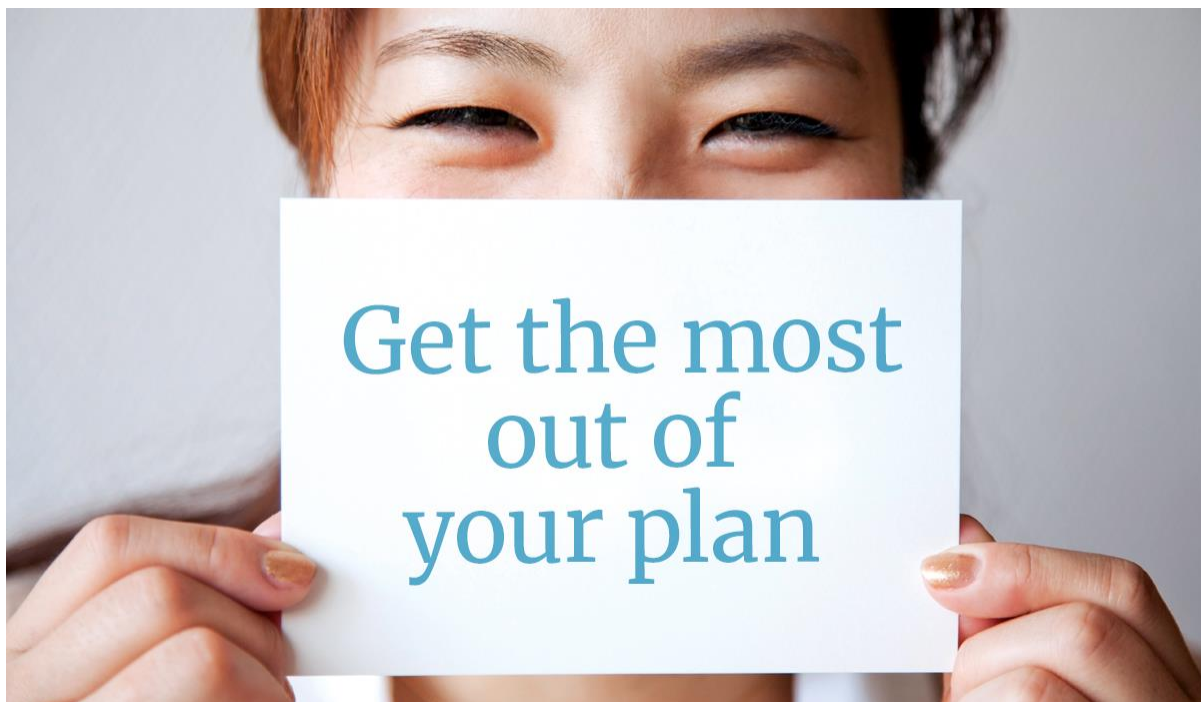
